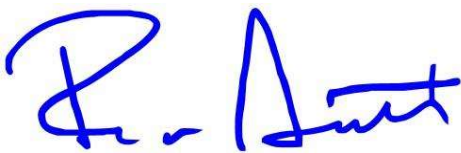
We write in support of the State of Florida's request for the U.S. Department of Agriculture (USDA) to issue a Disaster Declaration for Florida's counties that were impacted by Hurricane Idalia, and urge you to make assistance available immediately in the form of state block grants to support Florida's farmers and agricultural producers as they recover from the destructive impacts of the storm.
